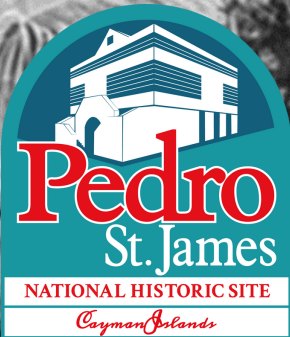

ADDITIONAL INFORMATION

1. Are prices in USD or KYD? All prices are in CI dollars. The exchange rate is 0.82.
2. Can the Thatch & Barrel and Side Lawn be sectioned off with a private entrance? Yes, Thatch & Barrel and Side Lawn can be sectioned off as one private event area with its own entrance, separate from the Courtyard.
3. Will there be someone present to manage the site while my event is on? Daily rate includes two on-duty staff for set-up, during and breakdown of your event for up to eight hours. Additional staff available upon request.
4. How does set up and breakdown hours work? Set up and breakdown usually takes two hours pre and post the event, depending on the size of event and equipment. Set up and breakdown time is included in the daily rate.
5. How does the deposit and payments work? Pedro St. James requires a 20% deposit to reserve your date. The balance is due 72 hours prior to the event. A non-refundable processing fee of \$100 is applied to all cancellations.
6. What is the cancellation policy? All cancellations are subject to a non-refundable processing fee of \$100. Rentals cancelled 30 days or more prior to the date of the event will receive a refund on the deposit paid and/or any other payments made, less the \$100 processing fee.
Rentals cancelled less than 30 days prior to the event will receive a 50% refund on the deposit paid, and 100% of any other payments made, less the \$100 processing fee.
Rentals cancelled less than 10 days prior to the event will receive no refund on the deposit paid, and 100% of any other payments made, less the \$100 processing fee, unless such cancellation is a result of force majeure or Pedro St. James Castle’s inability to provide the venue in accordance with the rental agreement.
7. Do estimates have an expiration date? Estimates are valid for 10 business days. All fees are subject to change without prior notice.
8. Are the rates listed negotiable? Rates listed represent the maximum fees charged and may be subject to change based on your specific requirements.
9. Are discounts extended to government or non-profit entities? Government and non-profit organisations receive a 40% discount on site rental.
